





### STARTER'S BONUS

- ✓ Starter's Bonus fund is taken from Travel fund

**Development Bonus:** 6% of Company Turnover of Calendar Month SV is distributed as DB.

- ✓ DB is shared with associates who balance minimum 25,000-25,000 Fresh SV in a Calendar Month.
- ✓ 25,000-25,000 Fresh SV balanced is distributed as one share, and maximum two shares are distributed per Business Centre (BC). Therefore, one can qualify two shares on each (01,02,03) BC.

#### For e.g. On a turnover of AP 100,00,000 Sv is 50 lakhs. 6% of SV is 3 lakhs.

- ✓ If there are 150 shares then the value per share is Rs 2000.
- ✓ Maximum Rs 4,000 DB an associate can achieve on one BC in this example.
- ✓ If a person qualifies on 3 BC on the same turnover he will get 8,000 DB in this example.



# STEP 5 Drive to your Dreams



Car Bonus: 5% of Company Turnover of Calendar Month's SV is distributed as Car Bonus. This is shared with associates who do minimum 1,25,000-1,25,000 Fresh SV balanced in a Calendar Month.

- √ 1,25,000-1,25,000 Sv fresh balance is to be taken as one share
  and one can achieve multiple shares on 01,02,03 BC.
- ✓ An Associate will have to maintain minimum "Ruby Director" title by last weekly closing of the month to qualify Car Bonus.

For e.g. On a turnover of AP 100,00,000 Sv is 50 lakhs. 5% of SV is 2.5 lakhs.

- ✓ If there are 50 shares then the value per share is Rs 5,000.
- ✓ If a person matches 2.5-2.5 lakhs in 4 weeks then he gets Rs 10,000 share.
- ✓ If a person qualifies on 3 BC on the same turnover the share will be 20,000 in this example.



## STEP BUILD a Dream House



**House Bonus**: 4% of Company Turnover of Calendar Month's SV is distributed as HB.

- ✓ This is to be shared with associates who do 2,50,0002,50,000 Fresh Sv in a Calendar Month's period.
- ✓ 2,50,000-2,50,000 Sv fresh balance is to be taken as one share and one can achieve multiple shares on 01,02,03 BC.
- ✓ An Associate will have to maintain minimum "Emerald Director" title by last weekly closing of the month to qualify House Bonus.

#### For e.g. On a turnover of AP 100,00,000 Sv is 50 lakhs. 4% of SV is 2 lakhs.

- ✓ If there are 25 shares then the value per share is Rs 8,000.
- ✓ If a person matches 5-5 lakhs in a Calendar Month then he gets Rs 16,000 share
- ✓ If a person qualifies on 3 BC on same business the share will be 32,000 in this example.







Royal Bonus: If an associate does a cumulative Fresh 50 lakhs-50 lakhs Sv in a Calendar Month's period then he will get 0.5% of his/her weak leg Sv done in this Calendar month's period as RB.

✓ RB can be qualified on all 3 BC separately.



**Offers & Incentives:** Company announces various offers on products/ promotional incentives from time to time.

**Activation Offer:** New Associate who activates ID within 7 days of registration with 1,250 SV, 2,500 SV or 5,000 SV gets products of around 8-10% of MRP free.

**Consistency Offer:** Associates who buy products worth 1250 SV, 2500 SV or 5000 SV continuously for three months get product worth 10—20% of MRP free.

Mini Stock Point: Open a Mini Stock point with 30,000/ 50,000/ 1,00,000 amount & get products worth MRP 2500/6000/ 12000 free.

Mini Stock Point Repurchase Sale: On sale of 50,000-2,00,000 in a month around 10% MRP products free.




